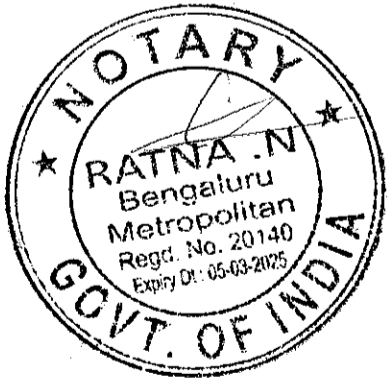

DISE CODE- 29200313703 FOR CLASSES 1st std to 8th std for a period of THREE(3) years and subject to fulfillment of following conditions.

1. This is a provisional grant of recognition under the RTE Act and rules and is not extendible beyond Class VIII.
2. The School shall abide by all the provisions of RTE Act 2009 and the RTE Rules 2010 referred here in.
3. The School shall admit in Class 1, to the extent of 25% of the strength of the class, children belonging to weaker sections and disadvantaged groups in the neighborhood and provide free and compulsory education till completion of elementary education. Provided that if the school admits children in pre primary classes also, the School shall follow these norms. The children so admitted shall not be discriminated from the rest of the children or segregated or treated separately in any manner.
4. For the children referred in Paragraph 3 the school shall be reimbursed as per section 12 (2) of the Act. In order to receive such reimbursements, the school shall open and maintain a separate bank account which is subject to audit by the department.
5. 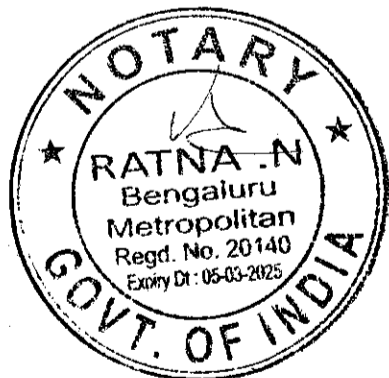

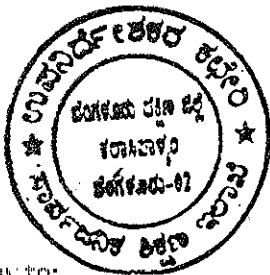
