Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school shall be restricted to 30 of which not more than 1/3rd sections may be used for senior secondary classes. The minimum size of Classrooms should be 8m x 6m (approximately) 500 sq. ft. but the school has only 8 classroom with above 500 sq. ft, 30 classrooms between 400 sq. ft to 500 sq. ft. Therefore, the school should restrict the enrolment to 32 per section. Any further increase shall require prior approval of the Board subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.

5	The lift should be installed for CWSN student to access upper floors and submit the compliance through the videography within 3 months on SARAS portal.

n I	The school shall ensure the training of its teachers with CoE Bengaluru within 3
	months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be
